4. The above approval is subject to the following conditions also mentioned in the Supreme Court order dated 12.04.2012: -

- a) The deficiencies pointed out in the staff will be removed by Sri Balaji Society within four weeks and a compliance report will be submitted to the AICTE within the said period of four weeks.
- b) The deficiencies with regard to the approval of the building plan will be removed by the end of June, 2012.
- c) The approval will be subject to the final decision in the SLP No. 5583 / 2012.

5. The above extension of approval is without prejudice to the rights and contentions of AICTE and subject to the final outcome of Writ Petition No. 1594/2012 and also pending Review Petition filed by AICTE in the said Writ Petition.

6. The approval is also subject to the following conditions: -

**"This Approval is granted without prejudice to and subject to the further orders as may be passed in Review Petition No. 56 of 2012 and in Writ Petition No. 1594 of 2012 pending before the Bombay High Court. You are required to communicate this condition to the students who may be admitted in the academic year 2012-13. The admission of the students as also the approval will be subject to the outcome of these cases."**

7. In case of any difference in content of this Extension of Approval Letter, the content/information as approved by the Competent Authority / Executive Council / General Council as available on the record of AICTE shall be final and binding.

8. **Strict compliance of Anti-Ragging Regulation:** - Approval is subject to strict compliance of provisions made in AICTE Regulation notified vide F.No. 37-3/Legal/AICTE/2009 dated July 1, 2009 for Prevention and Prohibition of Ragging in Technical Institutions. In case Institution fails to take adequate steps to prevent Ragging or fails to act in accordance with AICTE Regulation or fails to punish perpetrators or incidents of Ragging, it will be liable to take any action as defined under clause 9(4) of the said Regulation.
